



# Media Consent & Release

## The Agreement

By signing this “Release,” the undersigned “Participant” (referred to as me, or I) irrevocably (a) grants Schnebly Hill permission to take and use photographs, videos of me, recordings of my voice, use my name, use oral quotations and written statements about me or attributable to me, and record me in all media including retouched or otherwise modified derivatives (collectively, the “Recordings”); (b) assigns to Schnebly Hill all my right, title, and interest in the Recordings, including statements made by me regarding Schnebly Hill or its activities.

Schnebly Hill will be the exclusive owner of the Recordings, and may use or transfer ownership of them forever, whenever, for “Authorized Uses” including web site usage, social media, books, brochures, magazines, newspapers, lectures, the internet, Schnebly Hill website or other type of medium or publication.

Schnebly Hill will not pay me for the Recordings. To be clear: I expressly waive all moral rights in and to the Recordings, and hereby waive all claims to earn a royalty or other financial gain arising from the Recordings for myself, my successors, my heirs, and/or assigns.

I hereby release Schnebly Hill, and will indemnify, defend, protect, and hold Schnebly Hill harmless for, from, and against all claims, damages, or liability arising from the Recordings, including, but not limited to, defamation, libel, false light, invasion of privacy, rights of publicity, misuse, distortion, blurring, alteration, optical illusion, or use in composite form, either intentionally or otherwise.

This Release is governed by Arizona law. All claims arising from this Release shall be exclusively brought in federal or state court in Maricopa County, Arizona. If a provision of this Release is held to be unenforceable by a court of competent jurisdiction, then the remaining provisions of this Release will remain in full force and effect.
